# Year in review - 2021 COVID-19

- Prioritised response to the Global Pandemic
- Working with Government on gaining specific wine industry advice on COVID-19 restrictions
- Support for industry to understand the COVID-19 restrictions
- Advocating for Cellar Doors to open and trade during various (relevant) stages of restrictions
- Communication of vaccination requirements



# Year in review - 2021 covid-19

- Licensed Hospitality Fund, Business Support Package advocacy
- Agriculture as an essential service right to work
- Lockdown 3, 4, 5 & 6 restrictions right for cellar doors to open as retail when allowed

#### **Future Focus**

- Wine Victoria has operated for ten years;
- Providing a strong, united voice for the sector and representing our industry is vital for the long-term sustainability of all;
- Our mandate is growing, as are the issues we are facing; and
- As the State's peak body for the wine sector, our aim is to ensure that the industry can grow sustainably and that we have the right economic, community and policy frameworks in place to support that growth for our members.



#### 2022 State Election

Wine Victoria is preparing policy statements / funding requests as follows:

- Trade: 4-year funding for US strategy;
- Tourism: 4-year funding for marketing 5 pillars;
- Agriculture: 4-year funding for Viticulture Innovation Program;
- Drinks: ongoing funding for Drinks Victoria campaign;
- Wine and Health: reduced regulation, no minimum floor price;
- Recycling: ongoing commitment to '4th bin' for glass recycling (no wine bottles in container deposit scheme);
- Cellar Door: ongoing commitment to Victorian Liquor Subsidy;
- o Events: ongoing commitment to the regional events fund; and
- Local content: development of a local content policy.
